Kalyanrao (Balasaheb) Ingale Polytechnic College, Gat # 604/2, Near Bhakta Niwas, Ganagapur Road, Akkalkot, Dist.: Solapur, Maharashtra-413216** should submit the Compliance Report at least six months before the expiry of validity of accreditation mentioned above so as to be eligible for consideration by the concerned Committee in NBA for further processing of the accreditation status.
5. The accreditation status awarded to the programs as indicated in the above table does not imply that the accreditation has been granted to **Shri Vatavruksha Swami Maharaj Devasthan's Kai. Kalyanrao (Balasaheb) Ingale Polytechnic College, Gat # 604/2, Near Bhakta Niwas, Ganagapur Road, Akkalkot, Dist.: Solapur, Maharashtra-413216** as a whole. **As such the Institution should nowhere along with its name including on its letter head etc. write that it is accredited by NBA because it is program accreditation and not Institution accreditation.
